### **Shipping and handling fees:**

Within USA: \$7.01 (Priority Mail w/ Tracking)

Canada: \$7.01 (Airmail)

All other destinations: \$14.01 (Airmail)

Insurance is added at customer request

### **How long does it take to receive the order?**

The orders are normally processed within 1 to 5 business days. Shipping itself usually takes from 10 to 14 business days within USA and Canada, and from 10 to 30 business days for overseas packages. Delays may occur depending on clearing customs and your post office.

**Brazil, Mexico, Africa:** Add \$17.01 for shipping to these countries and all of Africa, due to package tracking requirements.
